## NOTICE OF FEE INCREASE

The Bureau of Security and Investigative Services (Bureau) is notifying all licensees that a regulatory package has been approved to amend Sections 638, 639, 640, 641, 642, and 642.5 of Article 8, Division 7, Title 16 of the California Code of Regulations (CCR).

These amendments implement a 10% increase to all eligible licensing fees. The new fee amounts will go into effect on **October 1, 2025**.

## Please note:

- Applications submitted in person or postmarked before October 1, 2025, will not be affected by the fee increase.
- Applications received or postmarked on or after October 1, 2025, will be subject to the new fees.
